I have lodged a Declaration of Compliance and Safety Equipment Checklist covering the Safety Category requirements listed in the Notice of Race for the races entered and I have lodged a copy of my current insurance certificate with the office. I understand Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". It is the competitor's decision to enter an event or to start and continue in any race. Competitors shall accept that their participation in an event is at their exclusive risk, in every respect. Hobson's Bay Yacht Club, its officers, members, servants and agents accept no liability in respect of loss of life, personal injury or loss or damage to property which may be sustained by reason of a competitor's participation or intended participation in an event or howsoever arising in connection with an event. All boats competing in an event organized by Hobson's Bay Yacht Club shall have racing insurance and third party insurance cover of not less than AUD\$5,000,000. All owners/competitors who sign the entry form are deemed to have made a declaration that they hold such cover. Competitors may be required to produce evidence of such insurance and any competitor not holding this cover shall withdraw their entry.
