Hobson's Bay Yacht Club, its officers, members, servants and agents accept no liability in respect of loss of life, personal injury or loss or damage to property which may be sustained by reason of a competitor's participation in an event or howsoever arising in conjunction with an event. All boats competing in an event organised by the Hobson's Bay yacht Club shall have racing insurance and third party insurance cover of not less than AUD\$5,000,000. All owners/competitors who sign the entry form are deemed to have made a declaration that they hold such cover. Competitors if asked will be required to produce evidence of such insurance and any competitor not holding tis cover shall withdraw their entry.
