All boats competing in an event organized by Hobson's Bay Yacht Club shall have racing insurance and third party insurance cover of not less than AUD\$5,000,000. All owners/competitors who sign the entry form are deemed to have made a declaration that they hold such cover. Competitors may be required to produce evidence of such insurance and any competitor not holding this cover shall withdraw their entry.
