All boats competing in an event organised by the Hobson's Bay yacht Club shall have racing insurance and third party insurance cover of not less than AUD\$5,000,000. All owners/competitors who sign the entry form are deemed to have made a declaration that they hold such cover. Competitors if asked will be required to produce evidence of such insurance and any competitor not holding tis cover shall withdraw their entry.
